SOUTHWEST ROANOKE AND IS OUR FIRST RESIDENTIAL TREATMENT PROJECT. WE
SIMULTANEOUSLY BEGAN APPLYING FOR GRANTS TO COVER THE CONSTRUCTION
COSTS TO REHAB IT (AND RECEIVED FUNDING FROM THE VIRGINIA OPIOID
ABATEMENT AUTHORITY TO COVER MOST OF THE COSTS, IN ADDITION TO OTHER
